

TERMS AND CONDITIONS – CONSTABLE CARE CLUB: MONTHLY PRIZE DRAW

1. The promoter of the Constable Care Club Monthly Promotion (Competition) is the Constable Care Foundation Inc ABN 643 998 656 31 (the Promoter).
2. The promotion is open to all registered Constable Care Club members who reside in Western Australia.
3. The monthly prize winner will be selected at random and notified on the first Monday of each month. Should the first Monday of the month fall on a public holiday, the winner will be notified on the next available working day.
4. Prize winners will be notified by phone. Constable Care Foundation, their directors, officers and employees, shall assume no liability resulting from incorrect contact details provided by the Entrant.
5. Prizes must be claimed in person unless a Winner is otherwise advised. Identification, which includes a photograph, will be required. Prizes will only be awarded following winner validation and verification. It is not the responsibility of Constable Care Foundation to deliver the prize to the Winner.
6. The Winner has four (4) weeks to collect their prize from the time they are notified, unless a prior arrangement has been made with a representative from the Constable Care Foundation. If the prize has not been collected by the Winner in the specified time range, the prize will be forfeited and go back into the monthly prize pool.
7. The Promoter reserves the right to either allow or disallow any entrant for any reason it sees fit in its absolute discretion.
8. A Prize must be taken as stated and is non-transferable, not exchangeable and not redeemable for cash. If the specified prize becomes unavailable for any reason, the Promoter may substitute a prize of like or equal value.
9. Entry to the Competition is not open to employees of Constable Care Child Safety.
10. The Judges' decision is final and no correspondence will be entered into. The Promoter reserves the right not to select Winners of all or any Prizes in its absolute discretion.
11. Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Competition, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any variation in prize value to that stated in these Terms and Conditions; (d) any tax liability incurred by a Winner or Entrant; or (e) use of a prize.

12. The Promoter reserves the right to disqualify a Winner if the Winner has breached any of the Terms and Conditions.
13. The Promoter reserves the right to:
 - a.) Declare as void any entries or claims for Prizes resulting from any printing, production or distribution errors or where there has been error in any aspect of the preparation for or conduct of the Competition materially affecting the result of the Competition or the number of Winners or the value of claims for Prizes;
 - b.) Add to or to waive any of the Terms and Conditions; and
 - c.) Cancel the Competition or any part of it at any stage in the event of circumstances beyond the Promoter's control.

In the event they are a Winner, the Constable Care Club member consents to the publishing of their names on the Constable Care Club quarterly newsletter and on the Constable Care Club members private Facebook page. The Promoter will not use the entrants' personal information for any other purpose without their consent unless required or authorised to do so by law. Entrants must notify the Promoter in writing if they would like to amend their personal information or if they have any queries as to how their personal information will be used.
